All Housing Authority of the Cherokee Nation buildings, whether leased or owned, and the grounds surrounding those facilities are considered by the HACN to be a tobacco free workplace; the Contractor will ensure all employees, subcontractors, and other workers will abide by this policy. Indian preference will be given only to contractor's who provide proof of current certification from the Cherokee Nation Tribal Employments Rights Office (TERO) located in Tahlequah, Oklahoma, telephone number 918-453-5000. Proof of TERO certification must accompany and be included in sealed bid submittal. This bid is subject to Section 7 (b) of the Indian Self-Determination and Education Assistance Act (25 U.S.C. 405 e) which requires in part that to the greatest extent feasible, preference in the award of the contracts and subcontracts shall be given to Indian Organizations and Indian Owned Economic Enterprises. Bid will be awarded to the lowest, most responsive/responsible bid.
