

Request for Sealed Bids Detailed Announcement

GENERAL:

The Housing Authority of the Cherokee Nation is seeking sealed bids from qualified contractors for the **Removing/Installing new Vinyl Sliding/Soffit, Seamless Guttering, Exterior Doors, (2) Mailbox Shed and (1) Gazebo for Ross Swimmer Addition, Projects 45-30 located in Tahlequah, Okla. (Total 15 Buildings and (1) Office)**

Interested parties are to provide bids to furnish all necessary labor, quality control, licenses, material, equipment, tools, supplies, permits, insurance and supervision to complete the entire project and to perform the work required thereof within the time specified after receipt of "Notice to Proceed". The entire project must be fully completed within 35 working days or \$1,000.00 per working day will be charged to the contractor for each day of extension over the presented construction end date. The Scope of Work and Specifications are available in the bid packet, along with all information and all necessary form documents. A bid bond or cashier's check equal to five (5%) of total bid must be included with the bid submittal.

Bid will be awarded to the lowest, most responsive/responsible bidder. The subsequent contract must be fully executed within (10) ten days of award or the bid will become null and void, and the next lowest most responsive/responsible bid will be considered. Contract award will be subject to the availability of funds.

The deadline for bids is **September 21, 2016, at 10:00 A.M.** The envelope containing the bids must be sealed and addressed to the Housing Authority of the Cherokee Nation, Attn: Duane White, P.O. BIDS MUST BE CLEARLY MARKED "SEALED BID, DO NOT OPEN, REMOVING/INSTALLING NEW VINYL SLIDING/SOFFIT, SEAMLESS GUTTERING AND EXTERIOR DOORS. FOR ROSS SWIMMER ADDITION. PROJECTS 45-30 RFSB #2016-001- 108". A PUBLIC BID OPENING WILL BE HELD ON SEPTEMBER 21, 2016 AT 10:01 A.M. IN THE HACN OFFICE LOCATED AT 1300 NOLA STREET (MOD BUILDING Conference Room 2nd floor), TAHLEQUAH, OKLAHOMA.
