OVERALL FLOOR PLAN

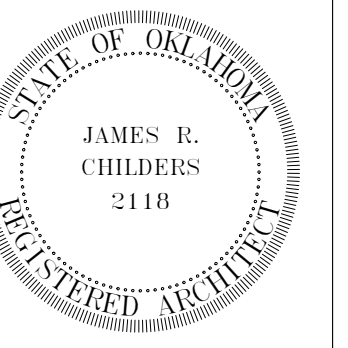

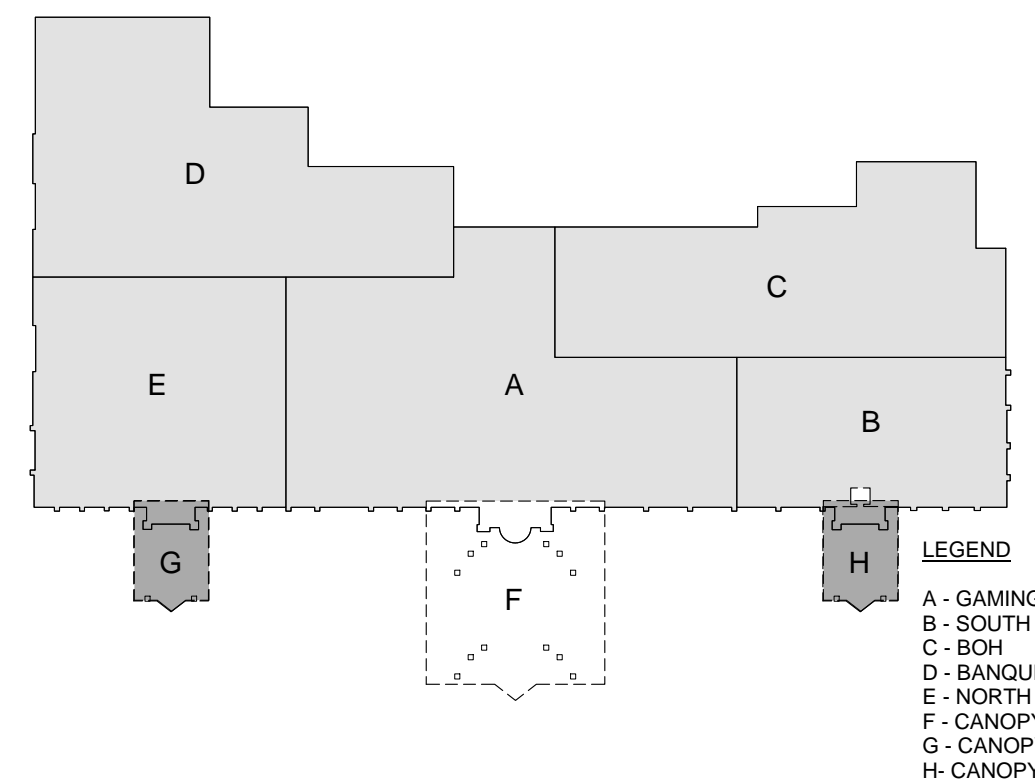
ENLARGED FLOOR PLAN - CANOPY



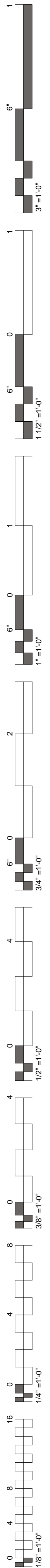
2 OVERALL FLOOR PLAN

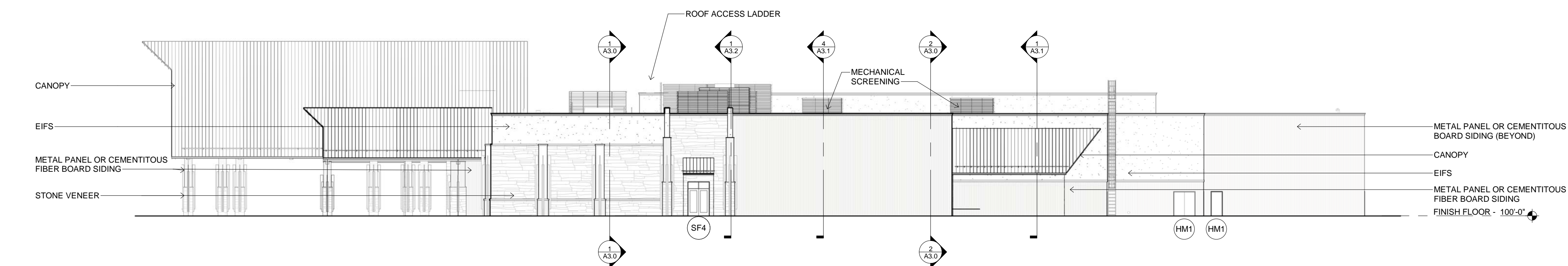
1 EXTERIOR ELEVATION

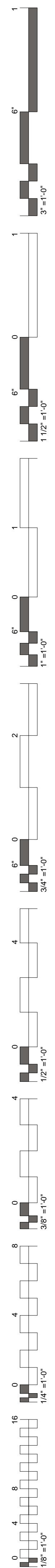
