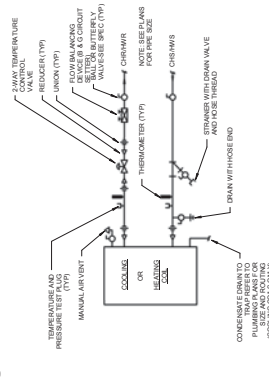
1 FIRST FLOOR FINISH PLAN - AREA 1

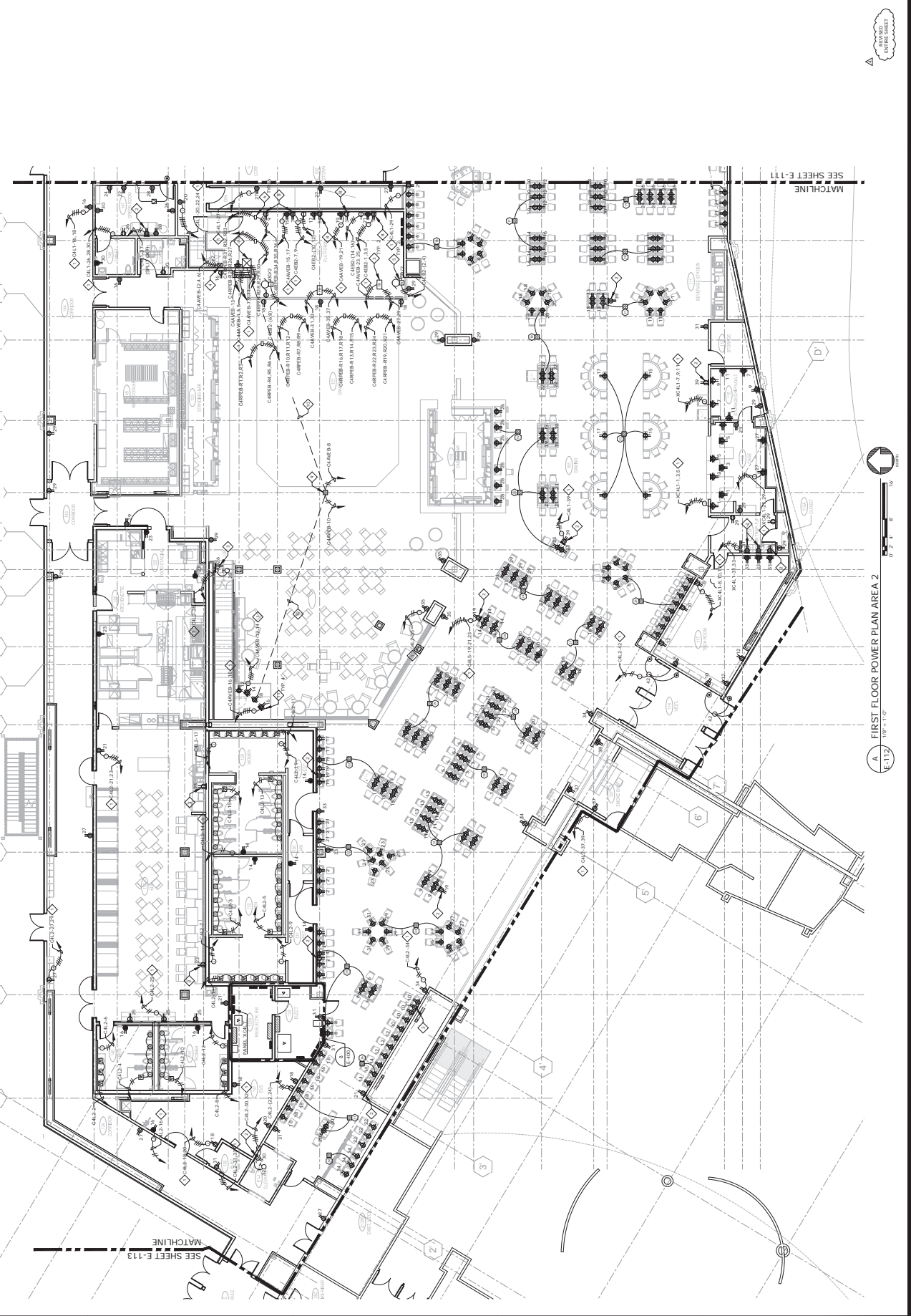

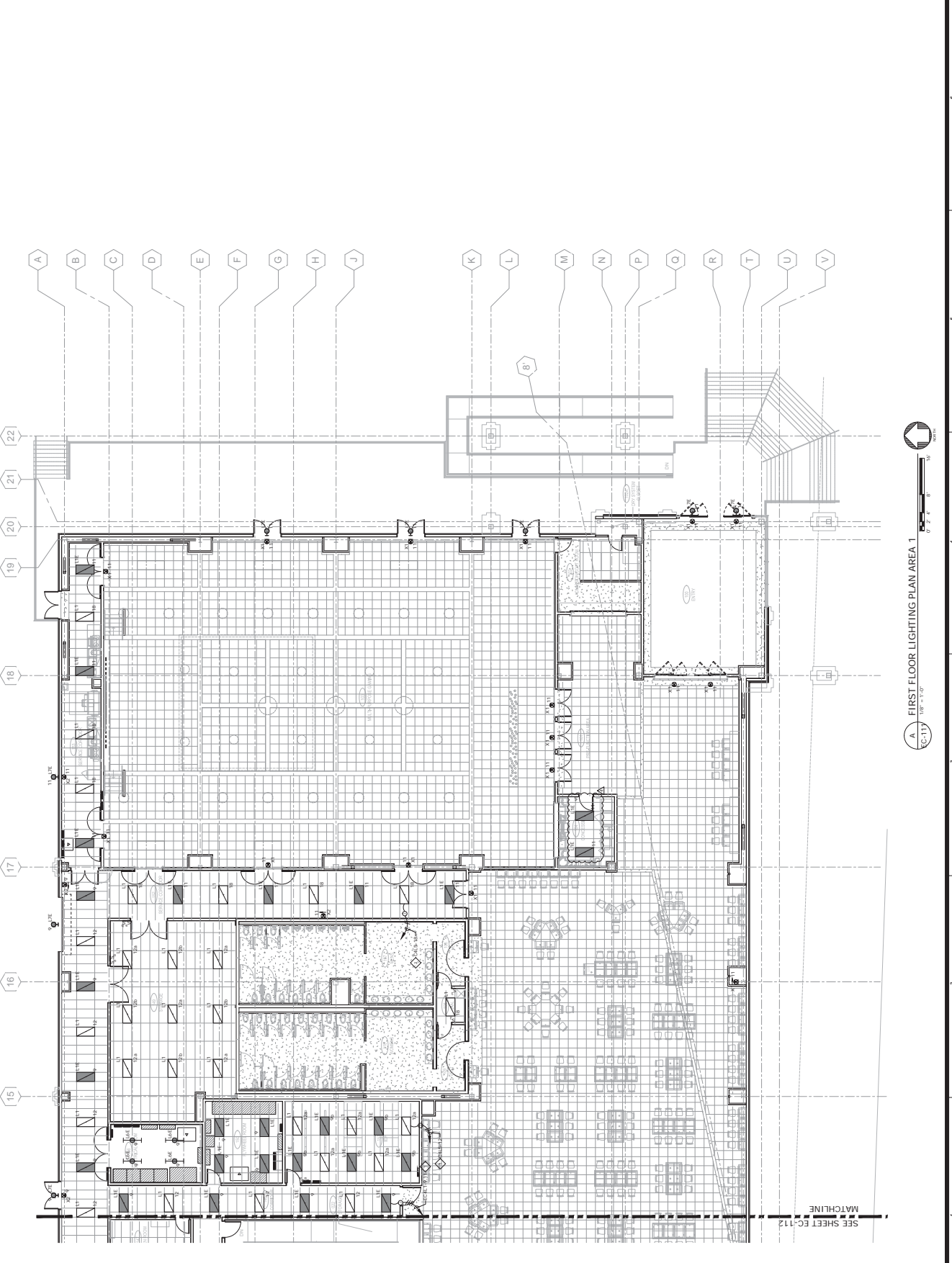

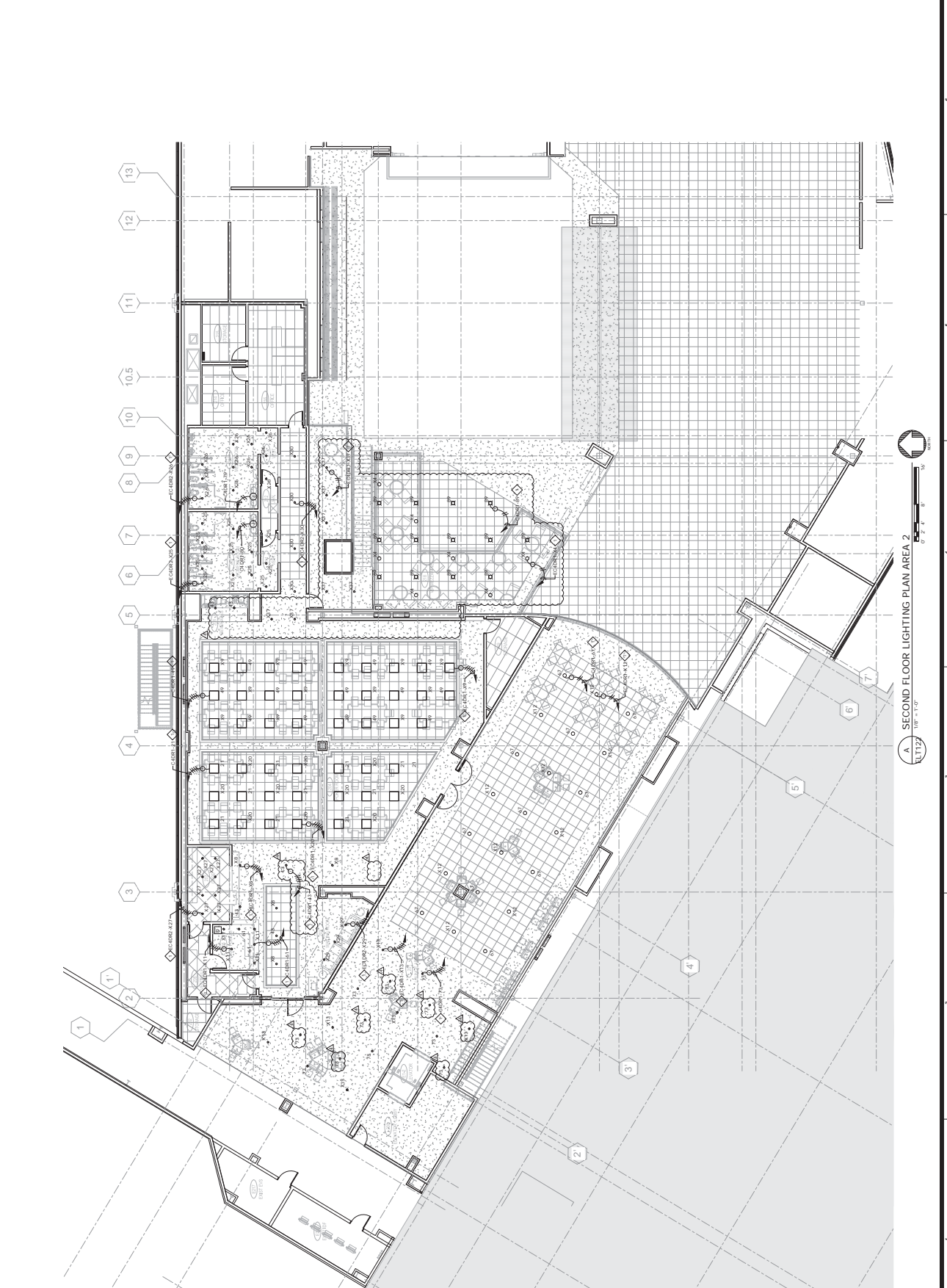

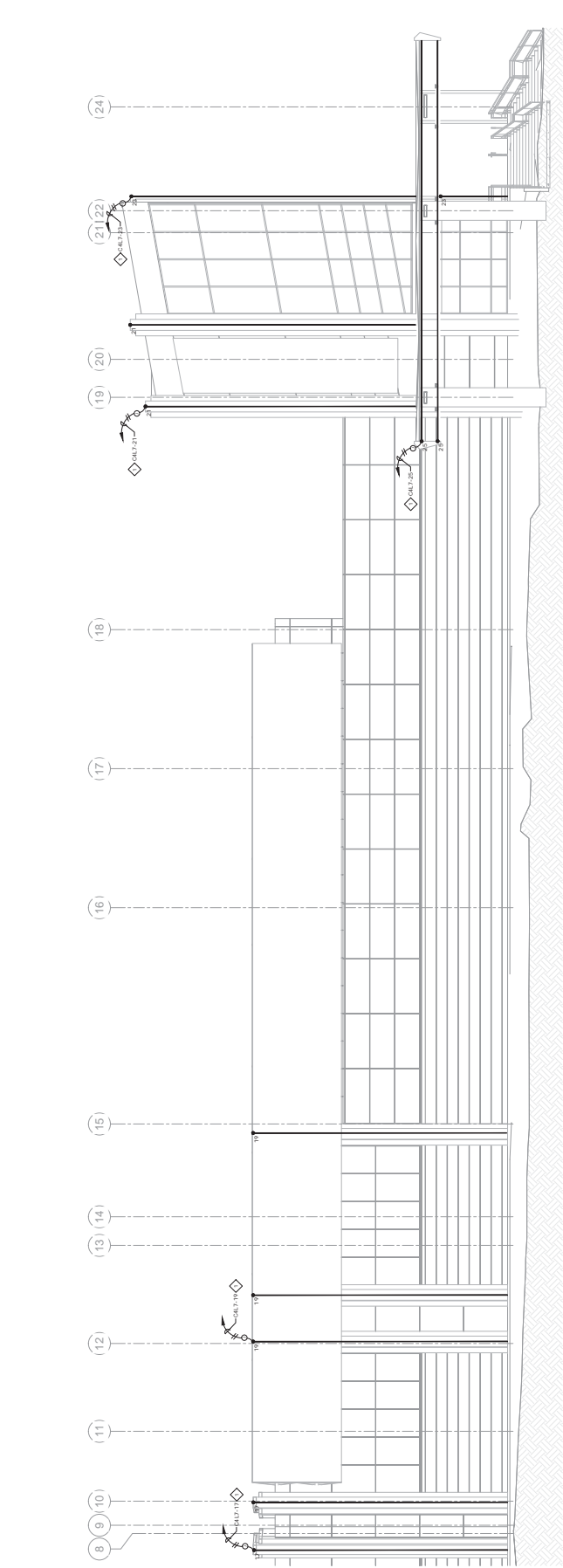

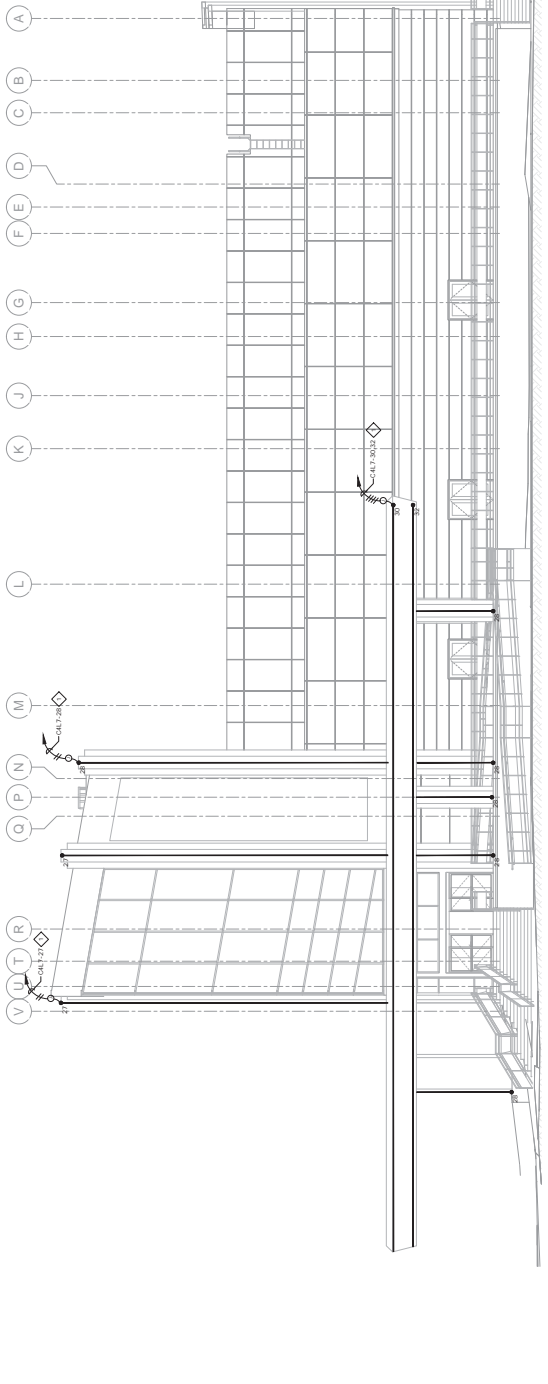

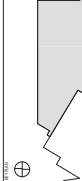
