BOUNDARY SURVEY PLOT PLAN

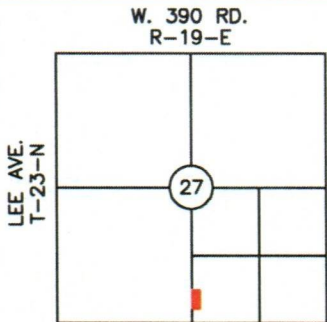

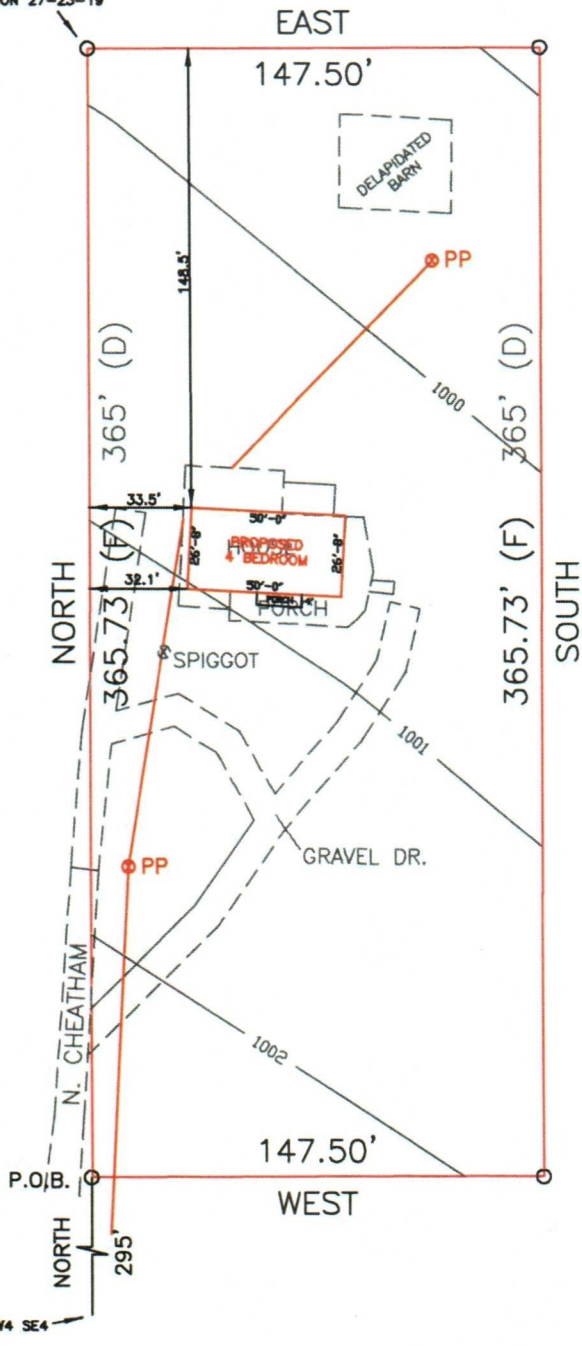
