The Housing Authority of the Cherokee Nation is seeking bids from interested parties for 50,000 Square feet of Luxury Vinyl Plank (LVP) Flooring and Approximately 35,000 Linear Feet of #623 5-1/4 Base trim, delivered to 1300 Nola St. Tahlequah, Oklahoma. Delivery of products must be no later than (10) ten working days after receiving purchase order. Bids must meet or exceed the following specifications attached. To be considered a responsive/responsible bidder, the mandatory bid response sheet must be fully completed. As well as sample of colors and spec sheet must be attached. Bids are due no later than November 14th, 2025, at 5:00 A.M.

### **MANDATORY SUBMITTAL INFORMATION:**

It is the bidder's responsibility to ensure delivery of bids by November 14, 2025, at 5:00 P.M. Bids received after the deadline will not be considered.

<u>Bid Acceptance</u>: Bids will be accepted from Indian and Non-Indian bidders. HACN reserves the right to determine if a bid meet stated requirements, and to award a purchase order for the bid that is in the best interest of the HACN, including but not limited to the total cost and capability of the bidder. Bidders are responsible for any and all costs associated with the preparation and submission of bids. To be considered, bids must be received by the specified date and time; any bid received after stipulated date and time will be returned unopened. No bidder may withdraw their bid within 30 days after the due date. HACN reserves the right to reject any and all bids.

<u>Cherokee and Indian Preference</u>: Indian preference will be given only to bidders who provide proof of current certification from the Cherokee Nation Tribal Employments Office (TERO) located in Tahlequah, OK. Proof of TERO certification must be included with the bid or provided within three (3) days of award. This contract is subject to Section 7(b) of the Indian Self-Determination and Education Assistance Act, which requires in part that to the greatest extent feasible, preference in the award of contracts and subcontracts shall be given to Indian Organizations and Indian Owned Economic Enterprises.

<u>Method of Award:</u> After reviewing all bids received, the purchase order will be awarded to the responsible bidder whose bid is determined to be the lowest and most responsive in accordance with the HACN Procurement Policy.
