QUESTIONS/ANSWERS:

1. Is the main entry door on the east side at the ramp going to remain as Aluminum (to be provided by others)? Or is it to change to steel door to match the other 3 exterior doors?

ANSWER: Contractor will provide an aluminum door with window (like in kind, quality, and installation as existing) for East Entry Door.

2. On the 2 new interior office doors are they to receive keypad locks or standard lever locks? And are they to have windows?

ANSWER: All interior doors will have windows and keypad locks.

3. On the exterior doors is it just the slabs or the entire door with new jams?

ANSWER: Entire door with jams.

4. Will base boards need to be replaced when replacing flooring?

ANSWER: Yes. LV Flooring and installation will include replacing baseboards.

5. What will be needed on the sink and millwork for the break area?

ANSWER: Cabinets will be the full length of the wall including both upper and lower cabinets for storage and a standard size kitchen sink. Contractor will also supply a new hot water source for the kitchen area and both bathrooms. It can be one source or individual tanks for each area.

6. Will a bond be needed if the amount is under \$250,000.00?

ANSWER: Yes. Cherokee Nation will not waiver the bonds for this project.

7. Will the building be occupied during the renovation?

ANSWER: We told the contractors during pre-bid it would be occupied but have since decided to relocate all workers. The building will be unoccupied.

This Bidder, in compliance with your invitation for a sealed bids for the renovation construction of the CNDOT Annex Building located in Tahlequah, Oklahoma (Cherokee County) and, having examined the bid documents; and, being familiar with all of the conditions surrounding the scope of work of the proposed project, hereby proposes to furnish all labor, quality control, materials, supplies, and supervision to complete the project for each site in accordance with the Contract Documents, and at the prices stated below. Indian preference will be given on this project to firms certified as Indian-owned by the Cherokee Nation Tribal Employment Rights Office (TERO). Proof of certification must accompany all bids.
