TERO – By Don Greenfeather

- Indian preference is required on this project.
- All subcontractors are to be TERO if at all possible.
- There is a TERO fee of one half of 1% of the total contract
- TERO has a job bank
- Any worker, both contractor and sub-contractor, who is not on the core crew list and non-Indian will require a TERO work permit
- The contractor's core crew is not subject to a TERO work permits

Overview of Plans – Wes Steward

- The plan layout of this project is 6 Mile Road first, County Line road second, and then Rocky Top Road. Though it is laid out this way, it is not the sequence of construction.
- At 6 Mile Road:
 - o It starts at Hwy 62 and goes 3 miles north
 - o There is curb and gutter at the beginning then the road straightens out and the typical section is cut ditches.
- County Line Road:
 - o On the west end an RCB located on 4 Mile Road will be replaced. It would be ideal to shut the road down and divert traffic to east and west County Line Road.
 - With several RCBs to be constructed it would be ideal to close the road to thru traffic, replace all the RCBs and then reopened

Northeast Fort Gibson Prebid Meeting

- Rocky Top Road:
 - Located on the north end
 - o It doesn't not go all the way through and it is a dangerous road
 - o This project will have a span bridge
- The whole project with the exception of the span bridge will be 2009 ODOT Standard Specifications
- The span bridge will use 1999 Standard bridge
- Course lab out of Tulsa will cast the beam and will have to make a modification on those beams. This modification should not be an additional cost to the contractor.
- Construction Sequence
 - Start constructing 6 Mile and dirt work on Rocky Top. The excavation on 6 Mile will help with the fill needed on Rocky Top.
 - o Complete all work on 6 Mile with the exception of asphalt.
 - Start County Line Road
 - The RCB under 4 Mile Road is to be completed before construction on County Line starts
 - Complete County Line with the exception of asphalt
 - o Finish work on Rocky Top Road and then asphalt the whole project
 - o Finish up any ditch grading

Questions

- What is the percentage of Native American workers required on this project?
 - There is no set percentage. The contractor is encouraged to employee as many Native Americans as possible
- Are there any boring logs?
 - o There are some in the plans for the bridge.
 - There are soil bores that were done for the roadway. Rocky Top was named for its rocky soil consisting mainly of sandstone. Holloway Updike & Bellen feels that it is rippable.
 - o The design borings and post them on the bidding website.
- The contractor is to use all the excavation from 6 Mile Road to fill on Rocky Top?
 - o That is the idea but the choice is up to the contractor to use the excavated material or haul it off and establish a borrow pit
- The roads are mainly paved. Why isn't there a pay item for asphalt removal?
 - o The roads are mostly chip and seal and not asphalt
- We are allowed to use as fill?
 - o Yes
- There is an 18" metal pipe. The bid quantity calls for 3,000 LF of pipe but the plans say but the plans say 2,478.
 - o It is a miscellaneous quantity under note 13 of general notes

Comments

- This project has been ongoing for a long time and there will be some parcels that have changed owners. There is a possibility that there will be additional driveways that are not in the plans. There is an additional quantity for that.
- The main concern is not having the whole project torn up at once. Try to maintain traffic on County Line Road while working on 6 Mile Road.
- All utilities have been relocated.
