All submission will be subject to Indian Preference based on TERO Certification. All submissions are still subject to review by the CN-IT Department to determine if the bidder’s submission meets or exceeds the product specifications as stated in the bid packet.

The following questions and/or requests for clarification were received by the deadline mandated in the Request for Sealed Bids.

QUESTION: In regards to the Camera and Equipment bid, would the Cherokee Nation be accepting pricing for a maintenance package for the equipment? If so, how would we submit pricing for those services?

RESPONSE: If you wish to provide additional information and costs, please provide the detailed information on a separate sheet with the sealed bid. Do not include these costs with the grand total for the equipment on the mandatory response sheets in the bid packet.

QUESTION: Is there any way you can give us the number of buildings and possible geographic footprint to help us create an alternative installation and maintenance package for you?

RESPONSE: No, parts only are required.

QUESTION: In regards to the Axis cameras for the attached surveillance bid, the 01006-001 Axis Q6000-E MKII 60Hz Network Camera is discontinued with no replacement. Can you please advise on what you would like me to replace it with or if you would like me to leave it off the bid?

RESPONSE: Please recheck with the regional representative for your company/area. There are still some available. If still unable to locate, contact the manufacturer/Axis direct and advise the bid that is being compiled, and ask for assistance.

QUESTION: We noticed this Request for Quote and it looks like we may be able to assist in providing you a price. We were just wanting to see if you could clarify if installation is needed, or if this only for parts.

RESPONSE: No, parts only are required.

QUESTION: Is this a bid for equipment only or does this bid/project require installation of the cameras and equipment?

RESPONSE: No, parts only are required.

QUESTION: Considering the current COVID-19 situation, will you be open to accepting email responses to the project in the subject line?
