Cherokee Heights:

- Liftable Dome Hoods are not acceptable. Enclosure must have door openings to ensure ease of accessibility and minimal exposure to weather during inspections and/or servicing.
- Drawing is unclear on if it is liftable dome hood or an enclosure with access doors. SCOPE provided lists liftable dome hood. Drawing shows external Emergency Pump Connection but, does not show how this is designed to enable lifting of dome hood. Drawings references TRACOM FRP building showing door openings (TRACO Bighouse?). Does this mean the FRP building is not standard supply to CLAY-GREENE prepackaged units?
- Package Station shall have generator and auto transfer switch mounted on steel skid pre wired and tested with UL Listing.
- Station shall come with a 4" magnetic flow meter mounted, tested, and integral to the manufacturers prepackaged station.

- Pump Data Sheets for the BARNES Pump is not submitted. Pump shall have a VORTEX Impeller made of Grey Cast Iron 35B, capable of passing 4" solids, Epoxy sealed cable to ensure cabling is NON WICKING, have Grey Cast Iron 35B construction, motor shall be cable of 20 starts per hours (min), Silicone Carbide Seal Facing on both upper and lower seals, 316 SS external hardware or better, Seals shall be Non Proprietary, Bearing life of 100,000 hours or over, 7 year warranty.

Sportsman Acres:

- Pump shall have a vortex impeller. Single or multi vane impellers are not acceptable.
- Bearing life not shown. Must be 100,000 hours or more.
- Cables shall be epoxy filled for NON WICKING if damaged.
- Pump shall have 7 year warranty. Warranty not shown in pre submittal.
- Pump shall be capable of a min of 20 Starts per hour. Literature shows 15 "evenly spaced" starts per hour.
- Dual Rail guide rail system is preferred to ensure ease of resetting pumps after inspection/servicing.
- Seals shall be Non Proprietary and readily available.
