- Attachment 1-D is how the contractor will use Indian preference

TERO – Presented by Regina

- Indian preference is required on this project.
- All subcontractors are to be TERO if at all possible.
- There is a TERO fee of one half of 1% of the total contract
- TERO has a job bank
- Any worker, both contractor and sub-contractor, who is not on the core crew list and non-Indian will require a TERO work permit
- The contractor's core crew is not subject to a TERO work permits

Overview of Plans – Russell Dixon

- This project is construction of 32' wide grading, drainage, and surfacing of an existing road
- There is a 1,000' section that is widened for a left turn lane as shown on typical section 2 on page 2
- There is a centerline rumble strip
- There is a driveway standard and in the plans a design for every driveway that is not standard such as being skewed
- Pay quantity sheet the asphalt millings are to be stock piled and will become property of the county
- Sheet 47 the area where the millings are to be stock piled as shown

- About 2/3 of this project (Sta. 12+00 to 47+00) will be in GRDA's levee control. The contractor is to coordinate with GRDA in this area.
- Sheet 5 take notice of the notes on this sheet.
 - o Traffic control for bridge B1 sequencing
 - The road can be closed to construction this bridge but not longer than 30 calendar days
 - O Contractor options there are some options. There are some precast for speed in time or there is the option to cast in place. There are designs for the cast in place.
- Sheet 7B There is a correction on the fence summary. The fence height of 6' is incorrect and should match the quantity sheet of 4' high fence. This correction will be in the addendum.
- There are strict restrictions on what can be done around the levee area. Any levee material disturbed must be kept separate from all other materials.
- Sheet 27 for bridge B1 road closure for the removal of the double 96" pipe and installation of boxes.
- Sheet 29 Two cross drain structures.
 - o East 530 Road Cast in place
 - o North 4460 Road Cast in place
- Sheet 33 Section of curb that ties into 447 Road
- Retaining walls located in the storm sewer system there is a deep ravine with no pipe. It is believed that the drainage flows through the soil. A storm sewer system will be constructed here with pipe and the design is included in the plans.

- The terrain in that area is too steep for a detour correct?
