**NOTES:**

2. Must be contract quality and suitable for commercial installation to withstand high traffic use, site conditions, humidity and weather conditions typical for the local and type of use.
3. Refer to drawings for exact locations of placements and mounting heights.
4. All quantities are to be verified by the purchasing agent and/or the contractor, including attic stock.
5. Manufacturer to verify in field all measurements and site conditions.
6. Must pass all codes required for contract installation including but not limited to local fire codes, ADA.
7. For specified upholstery, manufacturer is required to submit CFA to designer for written approval prior to production.
8. All cushions, foam padding and upholstered panels must be inherently flame retardant or treated to meet California Bulletin 117 and all other local, state and federal code requirements
9. All wood must comply with AWI "custom grade" or better quality standards. Wood construction is to be selected seasoned, free of knots, free of worms, or vermin, and kiln-dried to a moisture content not to exceed 6%. If imported, fumigation may be required depending on country of origin and certification.
10. All wood to be FSC certified in accordance with the Forrest Stewardship Councils' principle and criteria.
11. All adhesives and sealants used must be low emitting/ low VOC. Composite wood and Agri fiber products used must not contain urea-formaldehyde resins.
12. All hardware, including hinges, bolts, screws, etc., to be contract quality and non corrosive.
13. Metal grade and thickness to be commercial grade and withstand heavy hospitality usage. Manufacturer to ensure materials are non-corrosive, and all finishes are lowemitting.
14. Manufacturer to provide required hardware and instructions for proper installation.
15. All Electrical and Lighting fixtures to be UL Listed.
