1. Can you provide additional details on Alternate #3? Yes, details will be developed with Owner and artist after bidding. Contractor to provide a bid based on material size and quantities indicated. Which detail on A601? Reference should indicate A503 for Alternate #3 details.
2. I don't see any reflecting pool details for Alt #5 Refer L/7.02
3. My overhead door sub can't seem to locate size and operation of coil door. Specifications should include a basis of design as; Overhead Coiling SECURITY GRILLES - 670 SERIES with EEG UPCOILING SECURITY GRILLE - manually operated, 13' wide x 8'-1" tall.
4. I don't find any buttress details on the ASI drawings. Our only detail of the buttress is 2/L7.01 on ASI 1. Were they given our sheets last Monday that show the buttress rather than pier? Structural includes the plan view of the buttress in their footing detail on S101.
5. Is the fire alarm system to be new or is the existing to be modified? Who is the existing fire alarm manufacturer? The fire alarm system will be new. We do not have the documentation for the existing manufacturer and are working with MEP to confirm the design details.
6. Will voice and data cabling be provided by owner or is the GC responsible for the actual cabling? GC is responsible for cabling.
7. Is there a spec for the sail shade? Please advise. Material Schedule/L3.01 - Item 11.2 notes the manufacturer: INCORD 3/L7.01 - See drawing for dimensions of nets. - Noted materials: N371BL KNOTLESS NETTING 3/4" MESH and M125BL KNOTLESS NETTING 2" MESH - Noted color: CONTRACTOR TO PROVIDE PHYSICAL SAMPLES FOR COLOR SELECTION BY OWNER AND LANDSCAPE ARCH.
8. There is a vendor contact on A601 in the door schedule. Are all doors and hardware to be sole sourced from this vendor or are we allowed to price them elsewhere? Per ASI-1, equivalent products may be proposed, subject to architect approval
9. Is there a spec for the doors and hardware? Species?, Flush?, Paint or stain?, Hardware manufacturer?
