 - 1. HDMI input into switcher.
 - 2. XLR audio out from switcher.
 - Install two side displays.
 - 1. Contractor is responsible for determining how to attach to structure.
 - Install office display.
 - Install wall plate in office.
 - 1. HDMI input into switcher.
 - Install switcher in office.
 - 1. Switcher is to be connected to all four displays.
 - 2. Contractor to provide video input under main display.
 - 3. Contractor to provide video input in office.
 - 4. Contractor to label all inputs and outputs.
 - 5. Contractor to provide an audio out from switcher to wall plate under main display.
 - Contractor is responsible for connecting and testing the PA speakers and wireless microphone system.
- 2) **Testing** Contractor will perform a complete system test with CNE to verifyfunctionality.
- 3) **Training** Contractor will train CNE personnel on all system functions.

Deliverables

- 1) Provide a Warranty Letter to include equipment and installation warranty dates.
